SUBMISSION POLICY

1. The *Rivista di Scienze dell'Educazione*, RSE (*Journal of Educational Sciences*) welcomes articles, in Italian and in other languages, which are original and unpublished, i.e. which have not been published in other journals or works.
2. Contributions must have a size of 30,000 to 40,000 characters, including spaces. This limit does not include the notes and any tables and figures, which must be limited to the essential.
Reviews have a maximum size of 4,000 characters, including spaces.
3. Summaries - supplemented by 4-6 keywords - have a size of between 550 and 700 characters, including spaces.
4. Contributions must be accompanied by a brief presentation of the Author, indicating the institutional/academic affiliation, the field of research/teaching and the Author's origin.
A postal address - where will be sent three copies of the journal issue which Authors are entitled to by right - is also required.
5. Articles must be written in electronic format, using a word processor. Any additional formatting (*heading*, *body text*, etc.) has to be removed.
6. Contributions must be sent to the Scientific Coordinator at the following e-mail address: coordinatore.rse@pfse-auxilium.org.
7. Each contribution is put through a peer review process by referees guaranteeing the anonymity of both the reviewers and the Authors.
The referees are Italian and foreign experts, selected by the Scientific Coordinator, on the basis of their skills and research interests.
Authors may be required to modify or improve their articles, if the reviewers so suggest.
8. The evaluation of one's contribution is communicated by the Scientific Coordinator directly to the Author.
9. The Board of Directors reserves the right to publish the articles by intervening in the final editing phase and on the date it deems most appropriate.
10. Scientific collaboration with the journal is not remunerated.

After publication, the Author is sent three copies of the issue in which his contribution is published as well as the PDF of the article.

The Authors of works reviewed or officially mentioned by the journal in the sections *Recensioni - Review* and *Segnalazioni - Report*, will receive the relevant journal issue as evidence of their publication.

11. The Authors cede the copyrights to the *Rivista di Scienze dell'Educazione*, RSE (*Journal of Educational Sciences*).

12. In drawing up their contribution, the Authors must abide by the editorial standards shown below.

EDITORIAL RULES

Some criteria are given for the drafting of the text and the notes.

1. **TITLE** of the contribution: Arial 16, normal, capital letters
2. **AUTHOR**: Arial 12, normal, capital letters
3. **Titles 1st level**: Arial 12, bold, normal
4. **Titles 2nd level**: Arial 12, italics
5. Body text: Arial 11, line spacing 1.5, left-justified
6. Number of the notes in the text: after the full stop (and any other sign of punctuation).¹²
7. Footnote: Arial 10, left-justified.
8. Charts, tables, figures: must be drafted and sent in a separate file; they must be titled and numbered progressively and referred to in the text with the number. Their placement must be explicitly indicated in the text of the article.
8. Direct quotes in the text: in quotation marks «...»
9. Text omitted in the text: between square brackets [...]
10. Direct quotations in the notes: after the text of the quotation, the bibliographical indication is in round brackets.

If it is a reference:

11. The paragraphs in the body of the text are to be divided only by starting a new line, without indentation and space before and after.

12. The use of *italics* in the text should be limited to the words that are to be highlighted and to foreign terms not included in the common use of the Italian language.

13. Main abbreviations to be used after the reference has been cited the first time in full:

- cf cf - compare
- ID., EAD., - in place of the surname of the Author just mentioned above.

- *lvi* *ivi* - same author, same work just mentioned above, different page.
- *L. cit.* *l. cit.* - same author, same work, same page just mentioned above.

SURNAME Name, *Title. Subtitle*, City, Publisher and year of publication, quoted pages.

Edited by one author

Edited by two or more authors

Edited by more than three authors

AUMAN Jordan et ALII, *Problemi e prospettive di spiritualità*, Brescia, Queriniana 1987.

A work with more than one volume:

* BOOK IN A SERIES

Generally:

SURNAME Name, *Title. Subtitle* = Title of the series and number, City, Publisher and year of publication, quoted pages.

PAVAN Antonio, *La formazione del pensiero di J. Maritain* = Studi filosofici 14, Padova, Editrice Gregoriana 1967, 55.

* TRANSLATED BOOK

SURNAME Name, *Title* [Original title, City, Publisher year of publication], City, Italian publisher and year of publication, quoted pages.

MARITAIN Jacques, *L'educazione della persona* [Pour une philosophie de l'éducation, Paris, Librairie Arthème Fayard 1959], tr. it. di Piero Viotto, Brescia, La Scuola 1967, 20.

* CHAPTER FROM A BOOK (or Acts of a Congress)

SURNAME Name, *Title of the chapter*, in SURNAME Name of the Editor (edited by), *Title of the book*, City, Publisher and year of publication, pages cited (or overall number of pages).

* JOURNAL ARTICLE

Generally:

SURNAME Name, *Title. Subtitle*, in Title of the journal year of issue(civil year)issue no., pages.

FRANKL Viktor E., *La responsabilità non è un tabù. Vivere con senso in un mondo senza senso*, in *Ricerca di senso* 5(2007)2, 151-162.

* ENCYCLOPEDIA OR DICTIONARY ENTRY

SURNAME Name, *Title of chapter [or entry]*, in SURNAME Name of the Editor (edited by), *Title of the book [encyclopedia]*, vol., City, Publisher and year of publication, pages cited (or overall number of pages).

BIANCHI Carlo, *Le Università*, in ROSSI Francesco (a cura di), *Enciclopedia Italiana V*, Milano, Massimo 1965, 4-18.

* VOLUME OR ARTICLE FROM INTERNET

SURNAME Name, *Title*, in link, pages (date of consultation).
